The seconded was board compensation; if you travel to the park for meetings you get compensated. John Souza and Jon Mackenzie have both declined their compensation.

Terry Redwine: After speaking with several people we decided to reduce a couple of the rates for 2014. The weekly rate for Non Owners will be \$264, The Non Owner Snowbird Back In rate will be \$780 and the Non Owner Snowbird Pull Thru will be \$1190
