MANAGERS REPORT

Maintenance: Julio and Mike are in the process of finishing the siding replacement on the office. It should be done within the next few weeks. One heater has been installed for the pool. Another heater and ducting should be installed by the first of next week. Core sampling is set for December 21. This should give us an idea how to proceed on the asphalt repair.

Office: The Park has been decorated for Christmas. A big thank you to Janae & Aaron and the maintenance staff. Val from the Social Beach Club also did a great job decorating the tree in the club house. Kristi finished going through the deeds to insure their accuracy in RMS. We have fine-tuned the schedule for the office staff to insure the office is open 7 days from 8am-5pm. All lunch hours are being covered and sufficient staff is being scheduled for the busiest periods. Beginning next week, the staff will be preparing packets for the annual mail outs.

Manager: Site inspections were done and three letters of non- compliance were issued. It looks like the Wi-Fi issues have been resolved. We stayed within budget. TechSmith was able to negotiate a lower monthly price with Charter. Our monthly increase is very minimal for the additional modem. The quality of the signal is much better with doubling the bandwidth and adding two additional microwave dishes. (Refer to notes). Performance reviews have been finalized on all the staff.
